PREAMBLE :

In the reference 1st cited, the Government in G.O.(Ms) No. 190, dated: 30.07.2024 of Health and Family Welfare (PME-2) Department, has granted permission to Vandavasi Sambuvarayar Educational Trust, Vandavasi, Tiruvannamalai District to start B.Pharm. Degree Course with an annual intake of 60 seats at “S.R.I. College of Pharmacy” in Survey Nos. 402/1, 400/1B, 396A/1A, 396A/6, 445/4, 445/7 & 446/2, #321/15, Melmaruvathur Road, Birudur, Vandavasi, Tiruvannamalai District from the academic year 2024-2025.

2. In the reference 2nd cited, the Chairman, Vandavasi Sambuvarayar Educational Trust, Vandavasi, Tiruvannamalai District has requested for grant of Letter of Consent of Affiliation to start B.Pharm. Degree Course at **"S.R.I. College of Pharmacy"** in Survey Nos. 402/1, 400/1B, 396A/1A, 396A/6, 445/4, 445/7 & 446/2, #321/15, Melmaruvathur Road, Birudur, Vandavasi, Tiruvannamalai District, with an annual intake of 60 seats from the academic year 2024-2025.

3. In the reference 3rd cited, an Inspection was conducted on 22.08.2024 for the grant of Letter of Consent of Affiliation and the Inspection commission has submitted its report. Scrutiny of the inspection report revealed certain deficiencies. The said institution was directed to rectify the deficiencies and furnish compliance. The institution submitted the compliance report and the connected documents on 09.10.2024. Consequently, Letter of Consent of Affiliation was granted as in the ref. 4th cited.

4. In the reference 5th cited, the Chairman, Vandavasi Sambuvarayar Educational Trust, Vandavasi Taluk, Thiruvannamalai Dist, has requested to issue Provisional Affiliation order to start B.Pharmacy Degree course along with the approval of the Pharmacy Council of India (PCI), New Delhi.

5. In the reference 6th cited, the Pharmacy Council of India(PCI), New Delhi has granted approval to **"S.R.I. College of Pharmacy"** in Survey Nos. 402/1, 400/1B, 396A/1A, 396A/6, 445/4, 445/7 & 446/2, #321/15, Melmaruvathur Road, Birudur, Vandavasi, Tiruvannamalai District for 2024-2025 academic session for 60 admission for the conduct of 1st year B.Pharmacy Degree course.

6. An inspection was conducted on 12.12.2024 for the issue of Provisional Affiliation and the Inspection Commission constituted has submitted its report. Scrutiny of the inspection report revealed certain deficiencies. The said institution was directed to rectify the deficiencies and furnish compliance. The institution submitted the compliance report and the connected documents on 24.12.2024

7. The cut-off date for admission of students for B.Pharm. Degree course is 30.09.2024 for the academic year 2024-2025 and the extended cut-off date for admission of students for the academic year 2024-2025 is 30th November 2024. The Pharmacy Council of India(PCI) has not extended the cut-off beyond 30.11.2024. Hence, the Chairman, Vandavasi Sambuvarayar Educational Trust, Vandavasi Taluk, Thiruvannamalai Dist was informed to submit an Undertaking in INR 200/- Non Judicial Stamp paper by declaring that so far no students were admitted and will not admit any candidate hereafter in B.Pharm Degree Course for the academic year 2024-2025 in the event of grant of Provisional Affiliation.

8. In the reference 11th cited, the Chairmah, Vandavasi Sambuvarayar Educational Trust, Vandavasi Taluk, Thiruvannamalai Dist has submitted an Undertaking in INR 200/- Non Judicial Stamp paper by declaring that so far no students were admitted and they will not admit any candidates hereafter in B.Pharm Degree Course for the academic year 2024-2025.

9. The Governing Council in the Resolution No. 17, passed at the 305th GC Meeting held on 05.03.2025 has resolved to grant Provisional Affiliation Orders to **"S.R.I. College of Pharmacy"** in Survey Nos. 402/1, 400/1B, 396A/1A, 396A/6, 445/4, 445/7 & 446/2, #321/15, Melmaruvathur Road, Birudur, Vandavasi, Tiruvannamalai District run by Vandavasi Sambuvarayar Educational Trust, Vandavasi Taluk, Thiruvannamalai District for starting of B.Pharmacy Degree Course with an annual intake of Sixty (60) seats for the academic year 2024-2025 without student admission, since the cut-off date for admission into B.Pharmacy Degree course was already over for the academic year 2024 -2025.

ORDER:-

In pursuance to the Resolution passed by the Governing Council, the issue of the Letter of Consent of Affiliation, approval of the Pharmacy Council of India, New Delhi, the University Inspection reports and the Affidavit of Undertaking furnished by the Trust, the University grants the Order of Provisional Affiliation to Vandavasi Sambuvarayar Educational Trust, Vandavasi Taluk, Thiruvannamalai Dist to start B.Pharm. Degree Course with an annual intake of 60 seats in the name and style as **"S.R.I. College of Pharmacy"** in Survey Nos. 402/1, 400/1B, 396A/1A, 396A/6, 445/4, 445/7 & 446/2, #321/15, Melmaruvathur Road, Birudur, Vandavasi, Tiruvannamalai District from the academic year 2024-2025, subject to conditions that not to admit candidates for the academic year 2024-2025 as the cut-off date fixed by the relevant Pharmacy Council is over by 30.11.2024.

- a. This order is granted subject to usual terms and conditions which are as follows:-
1. The admission procedure as laid down in Govt. order, Health and Family Welfare (MCA1) Department should be followed strictly. The seats available in B.Pharm. Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of admission for the Management quota as per orders in force.
 2. The candidates should have been admitted before the cut off date.
 3. The Trust should agree for the Inspection of the College by the Tamil Nadu Dr. M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Pharmacy College framed from time to time.
 4. The Candidates admitted will take up their 1st B.Pharm. Degree Examination as per the existing regulations of this University.
 5. The Trust and the Pharmacy College should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of syllabus, Examinations, Code of conduct, extracurricular activities, etc.
 6. The conditions that may be prescribed by the Pharmacy Council of India, New Delhi shall be fulfilled and the rules and regulations of the central council shall be followed strictly.
 7. Only qualified staff shall be appointed to handle the classes in the B.Pharm. Degree course.
 8. No Unqualified staff shall be appointed.
 9. Only eligible candidates according to the regulations of this University shall be admitted to the I B.Pharm. Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
 10. The sanctioned strength for said Degree Course should not be exceeded.
 11. There shall not be any financial Commitment either to the University or to the Government.
 12. Hostel accommodation shall be made available for the students both Male and Female separately.
 13. The admission of students should be made after the date of issue of this proceeding.
 14. Required furniture shall be provided wherever they are necessary.
 15. Furnishing of false information to the University on any approval matter or suppression of facts while furnishing information to the University or Violation of any of the Statutes, Ordinances, Regulations, Rules, instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.

16. The Institution shall show evidence of an annual income of not less than Rs. 4,00,000/- (Rupees Four lakhs only) excluding the interest accrued from the Security Deposit mentioned in the statutes to facilitate the proper running of the proposed Pharmacy College.
17. The College shall furnish a "Utilisation Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Pharmacy College.
18. The Trust shall have a duly constituted Governing Body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.
19. The Governing Body of the College shall meet at least once in every three months to consider the Budget Estimates and such meet in May – June each year to consider the Annual Report, the audited statement of accounts, changes in the pattern of staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year, etc. A Copy of approval notice of the meeting shall be sent to the Registrar, atleast 15 days before the date of the meeting. A copy of the minutes of the meeting shall also be sent to the Registrar of this University within 15 days from the date of the meeting.
20. The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the first and second year of the course of study.
21. The Provisional Affiliation now granted by the University is for the first year of B.Pharm. Degree Course only.
22. After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University by the time only six months period is left for the first year B.Pharm. Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year B.Pharm. Degree Course of study.
